It is our pleasure to welcome you to New York and to the 34th Annual Spring Meeting of Division 39.

Conflict is located at every layer of our experience—whether conceptualized within the structural or topographic models, intersubjectively determined emotional experience, the impact and constrictions of social norms and social traditions, or governments, spiritual beliefs, nations, and between factions of psychoanalysts.

On Saturday, **Dr. Eric Klinenberg**, Professor of Sociology, New York University, will present “Developmental Conflict? Going Solo: The Extraordinary Rise and

Surprising Appeal of Living Alone.” Running counter to conventional wisdom and some versions of developmental theory, he will introduce us to his research showing that those who do not partner or marry are hardly unhappy, disengaged, or necessarily troubled.

From the **Master Classes** and **Opening Event** panel on Wednesday, through the **Closing Event** panel midday Sunday, the conference schedule is rich in conflict, interaction, and opportunity for affiliation. We hope that you feel engaged and reluctant to miss a moment of the program. But do! You will be steps from Times Square and Central Park, and a short subway or cab ride to museums, restaurants, neighborhoods and locals, and we encourage those of you visiting New York to experience the warm and enriching conflicts to be found wandering among over 8 million residents and 20 million metro area neighbors.

Continuing Education Credits

The Division of Psychoanalysis is approved by the American Psychological Association to sponsor continuing education for psychologists. Division 39 maintains responsibility for these programs and their content.

Sexual Conflict in Couples: Discrepant Desires and Lost Attractions

Some of the most challenging clinical moments for couples and therapists are when couples reveal discrepant sexual desire or an absence of sexual attraction. Attraction may be described as something that was once present but lost, something that never existed, or as a difficult struggle to manage feelings of physical disgust. Unlike sexual desire that may wax or wane depending on intrapsychic, interpersonal, developmental, or environmental factors, sexual attraction is often experienced as fixed and unchangeable. Sitting with Conflict: Affect Tolerance and Disorders of Self-Care

Panelists will explore Henry Krystal's view that traumatic failures in early object relations contribute to an inability to tolerate conflict, which is reflected in addictive behavior such as substance abuse and eating disorders. These disorders of self-care contain multiple meanings and functions; for example, eating disordered symptoms can be understood as a way to simplify the frightening complexities of the relational world. The Parent-Infant Psychotherapy Program (PIP) is a two to three-year clinical training program in parent-infant psychotherapy offered by the Columbia University Center for Psychoanalytic Training and Research. The PIP program provides a comprehensive training in relationally based and psychoanalytically informed parent-infant psychotherapy. The program is unique in bringing together applicants from diverse backgrounds: psychiatrists, psychologists, social workers, occupational therapists, pediatricians, and psychoanalysts.

This in-depth training includes advanced didactic course work, infant observation, clinical placements, and supervision by members of the Columbia Psychoanalytic Center faculty. The goals of the program are to enhance the clinician's theoretical understanding of the complex developmental and dynamic aspects involved in infant mental health and early childhood psychopathology and parenting, and to develop clinical expertise in dyadic and triadic psychotherapy techniques that support optimal parenting, infant development, and parent-infant relations.

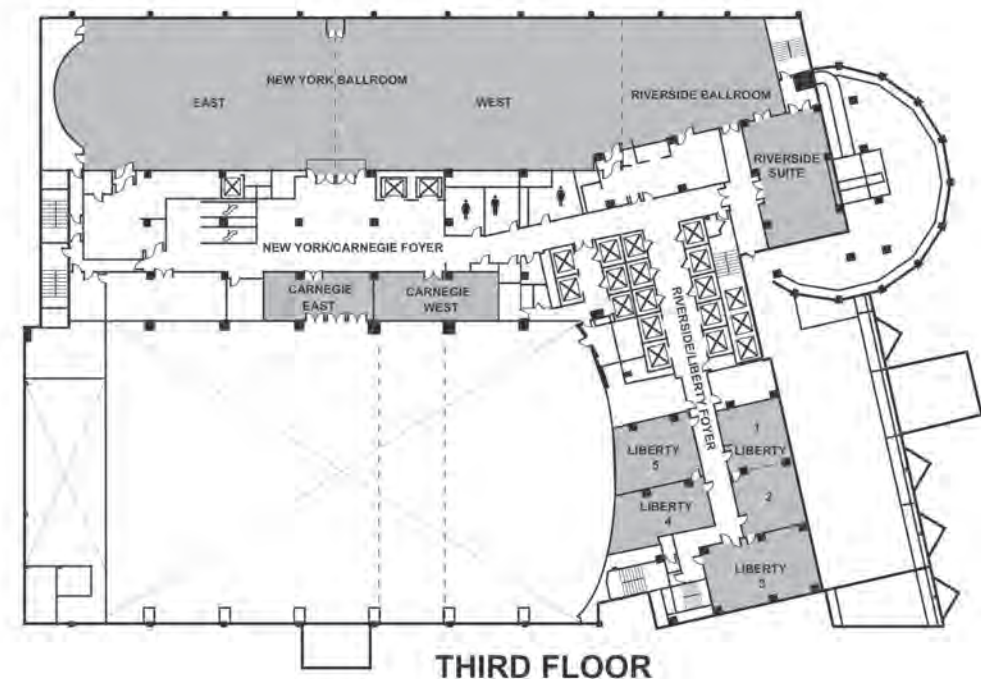
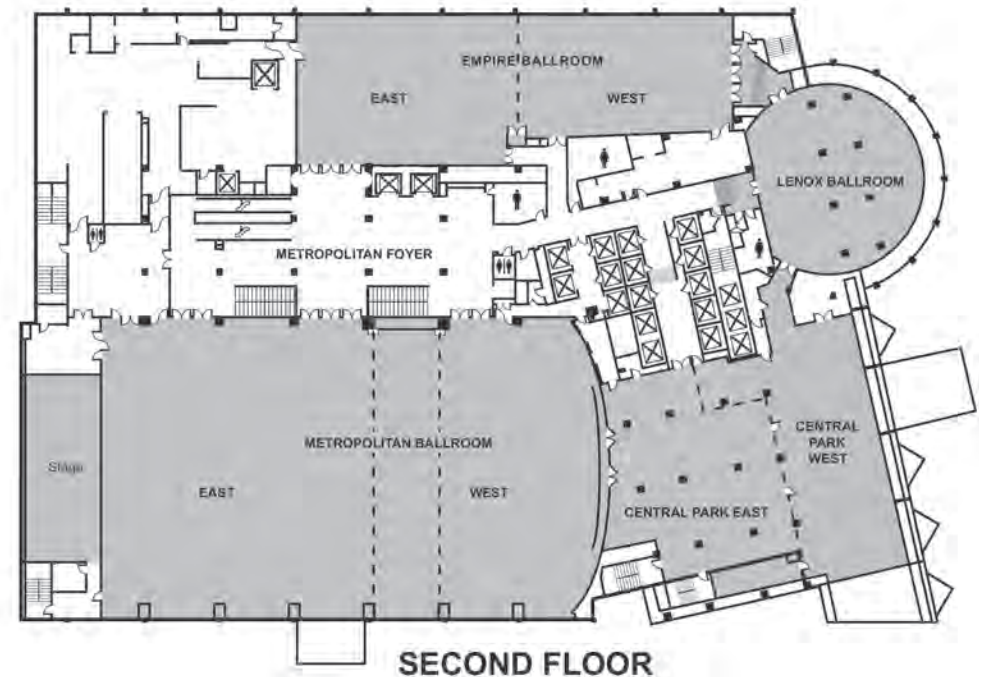

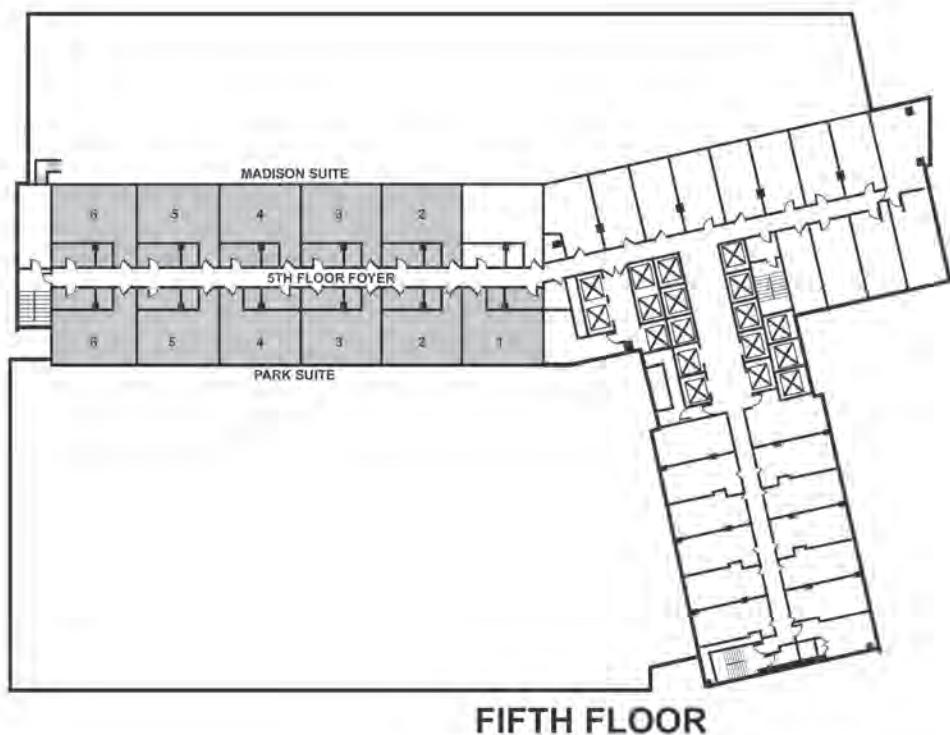
