Continuing Education Credits

The Division of Psychoanalysis is approved by the American Psychological Association to sponsor continuing education for psychologists. Division 39 maintains responsibility for these programs and their content.

Amount Of Continuing Education Available

Each 1 hour and 50 minute program is available for 1.5 CE Credits. Participants have the ability to accrue up to 21 CE Credits by attending programming throughout Thursday to Sunday. For all CE-eligible programs, there is no partial credit for attending only a portion of an eligible program.

How to Receive CE

To receive a Certificate of Attendance for any CE-eligible program, it is necessary to

1. Register for the Spring Meeting
2. Attend the entire presentation
3. Return a completed evaluation form and CE Log

Each CE-eligible program is identified by a letter/number code (i.e., TH-1, FR-3, SA-5, SU-2) indicating the day of the presentation and its order in that day's schedule. This code will match the program's listing on the Continuing Education (CE) Log, which is each participant's official record of attendance at CE-eligible programs. 50-minute programs are not available for continuing education credits; other presentations that are not available for continuing education credits are identified as such. Couples on the Couch: Principles of Psychoanalytic Psychotherapy with Couples

Shelley Nathans, Ph.D. and Milton Schaefer, Ph.D.

This intermediate seminar will teach a model of Psychoanalytic Couples Psychotherapy originally developed at the Tavistock Marital Studies Institute. Utilizing Neo-Kleinian and Bionian concepts such as Projective Identification and Containment with a focus on transference and countertransference phenomena, the model explicates a way of understanding the often entrenched and deeply troubling interactions between couples. Interpretation of the ways that the couple uses each other and the therapist to both communicate and defend against primitive anxieties can be extremely useful in addressing the couples' shared unconscious phantasies. Case examples will illustrate techniques of addressing barriers to the couple's curiosity about themselves and each other which can then lead to both greater differentiation and intimacy.

Make the Mountain Dance: Koans for Psychotherapists

Megan Rundel, Ph.D.

In this introductory workshop, we will explore the use of Zen koans for psychotherapists. We will begin with a short presentation on the history of koans, and describe their utility in reaching layers of the unconscious and promoting creativity and flexibility. We will then spend time meditating with koans in mind, and work together as a group to inquire into our experience with the koans. No experience with koans is necessary, but curiosity and an open mind are helpful.

Writing as Coming into Being: Writing Workshop for Beginning and Experienced Writers

This workshop is for beginning and experienced writers who are interested in writing in ways that help evoke the unconscious experiences in analytic work—forms of writing that can bring us and our clinical experience more fully into being. We will explore how writing can be also used as an aid when we are in the midst of clinical difficulties or impasses. The workshop will be a mix of reading examples, exercises that help us gain greater access to the unconscious processes, and discussion. Discussion will include looking at strategies for dealing with anxieties about both the necessary grandiosities, and the inevitable blocks involved in the writing process.

On Reclaiming the Treatment of Pain Syndromes and Somatic Disorders for Psychoanalysis: A Comprehensive Exploration and Review

Marilyn Jacobs, Ph.D., ABPP, Eric Sherman, Psy.D., Lekeisha A. Sumner, Ph.D.

This interactive workshop will provide an integrated model for the psychoanalytic evaluation and treatment of patients with chronic pain, medically-unexplained symptoms and somatic distress. A historical review of how psychoanalysis has approached this area of practice beginning with Freud to the present will be outlined. The consequences for medical patients when subjective inner experiences are neglected and aggressive medical therapies are favored with the goals of psychotherapy limited to conscious control over symptoms, and stress management will be explained. The workshop will illuminate how Western-oriented science neglects cultural influences in understanding the pain experience as well as how patients from diverse backgrounds may be afforded sub-optimal psychological care. Participants will be encouraged to discuss case material.

Vicarious Traumatization: A Dialogue with Ghislaine Boulanger and Stephen Xenakis



Ghislaine Boulanger, Ph.D.

Ghislaine Boulanger is a psychologist and psychoanalyst in private practice in New York City and a member of the Relational faculty at New York University's Postdoctoral Program in Psychotherapy and Psychoanalysis. She is currently president and president elect of Section V, the Section for Applied Clinical Psychoanalysis of

Division 39 and on the board of Section IX of Division 39, Psychoanalysts for Social Responsibility. Previously, with Ruth Fallenbaum, she was co editor of the Section IX newsletter, *The Psychoanalytic Activist*. Since the publication of her book, *Wounded by Reality: Understanding and Treating Adult Onset Trauma*, Dr. Boulanger has taught and published extensively on the psychodynamic dilemmas facing adults who have survived violent and life threatening events, and on the consequences for the clinicians who work with them. The latter is the topic of this keynote conversation.

Stephen Xenakis, M.D.

Brigadier General (ret.), Chief Medical Officer, MindCare Solutions, Nashville, TN

Dr. Xenakis is a psychiatrist with an active clinical and consulting practice. He is the Founder of the Center for Translational Medicine that develops treatments and conducts tests on brain related conditions affecting soldiers and veterans. He has been a senior adviser to the Department of Defense on a wide range of issues concerning the care and support to service members and their families. Retiring at the rank of brigadier general, he served 28 years in the United States Army as a medical corps officer. Dr. Xenakis has written widely on medical ethics, military medicine, and treatment of detainees, including book chapters and legal reviews and appears regularly on national radio and television. He is currently working on the clinical applications of quantitative electroencephalography (QEEG) to brain injury and neurobehavioral conditions and promoting integrative care programs for veterans. Dr. Xenakis is an Adjunct Professor at the Uniformed Services of Health Sciences of the military medical department. He is a graduate of Princeton University and the University of Maryland School of Medicine.

Sex, Love, and Kinship in the Twenty-First Century

The two panel series, Sex, Love, and Kinship, explores being and living in a post-millennium world that has moved beyond solely binary or dyadic categorizations in the organization of self and self and other.

In Part I, The Fate of the Dyad, the panel will consider the growing number of non-dyadic relationships in family formation, child rearing, and romance. In Part II, The Fate of the Binary, the panel will explore the challenges to and shifts in thinking about heretofore dualistic categories of gender, of coupling and parentage, of sexuality.

The increasing fluidity of the world demands a willingness to explore hard questions in the above areas. She served as the Founding Director of the Asian Mental Health Program at Cambridge Health Alliance, and the Co-Director of the Trauma and Loss Program at Georgetown University Hospital. She has presented nationally and published peer reviewed journal articles and book chapters on the topics of immigration, ethnic minority issues, trauma, and psychoanalytic psychotherapy. She is a recipient of the Collaborative Fellows Grant from the Lynch School of Education at Boston College. Her research focuses on the experiences of race and immigration among youth and adults, and on the experience of traumatic stress among immigrant communities. She is the recipient of the American Psychological Association Division 39 2013 Johanna Tabin Book Proposal Prize, and her book concerning culturally informed practice from a psychoanalytic perspective is forthcoming. Ghislaine Boulanger, Ph.D.

Ghislaine Boulanger is a psychologist and psychoanalyst in private practice in New York City and a member of the Relational faculty at New York University's Postdoctoral Program in Psychotherapy and Psychoanalysis. She is currently president and president elect of Section V, the Section for Applied Clinical Psychoanalysis of Division 39 and on the board of Section IX of Division 39, Psychoanalysts for Social Responsibility. Previously, with Ruth Fallenbaum, she was co editor of the Section IX newsletter, *The Psychoanalytic Activist*. Since the publication of her book, *Wounded by Reality: Understanding and Treating Adult Onset Trauma*, Dr. Boulanger has taught and published extensively on the psychodynamic dilemmas facing adults who have survived violent and life threatening events, and on the consequences for the clinicians who work with them. The latter is the topic of this keynote conversation.



Stephen Xenakis, M.D.

Brigadier General (ret.), Chief Medical Officer, MindCare Solutions, Nashville, TN

Dr. Xenakis is a psychiatrist with an active clinical and consulting practice. He is the Founder of the Center for Translational Medicine that develops treatments and conducts tests on brain related conditions affecting soldiers and veterans. He has been a senior adviser to the Department of Defense on a wide range of issues concerning the care and support to service members and their families. Retiring at the rank of brigadier general, he served 28 years in the United States Army as a medical corps officer. Dr. Xenakis has written widely on medical ethics, military medicine, and treatment of detainees, including book chapters and legal reviews and appears regularly on national radio and television. He is currently working on the clinical applications of quantitative electroencephalography (QEEG) to brain injury and neurobehavioral conditions and promoting integrative care programs for veterans. Dr. Xenakis is an Adjunct Professor at the Uniformed Services of Health Sciences of the military medical department. He is a graduate of Princeton University and the University of Maryland School of Medicine.

Dr. Gottdiener has been a visiting scholar at The Austen Riggs Center and St. Luke's-Roosevelt Medical Center in New York City. He is also the recipient of awards for teaching excellence and student mentoring. He is an APA Fellow in the divisions of psychoanalysis, addictions, and general psychology; a Fellow of the International Psychoanalytic Association and an active member of the American Psychoanalytic Association. His research interests focus on personality and psychodynamic factors that contribute to the development, maintenance, and treatment of substance use disorders. 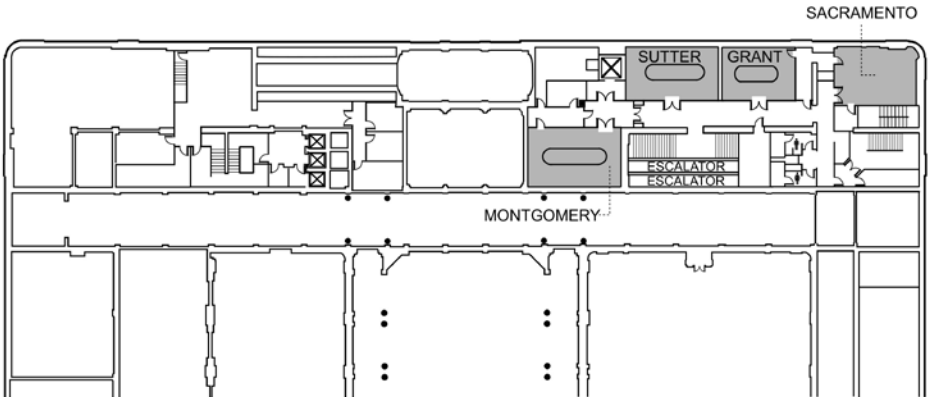

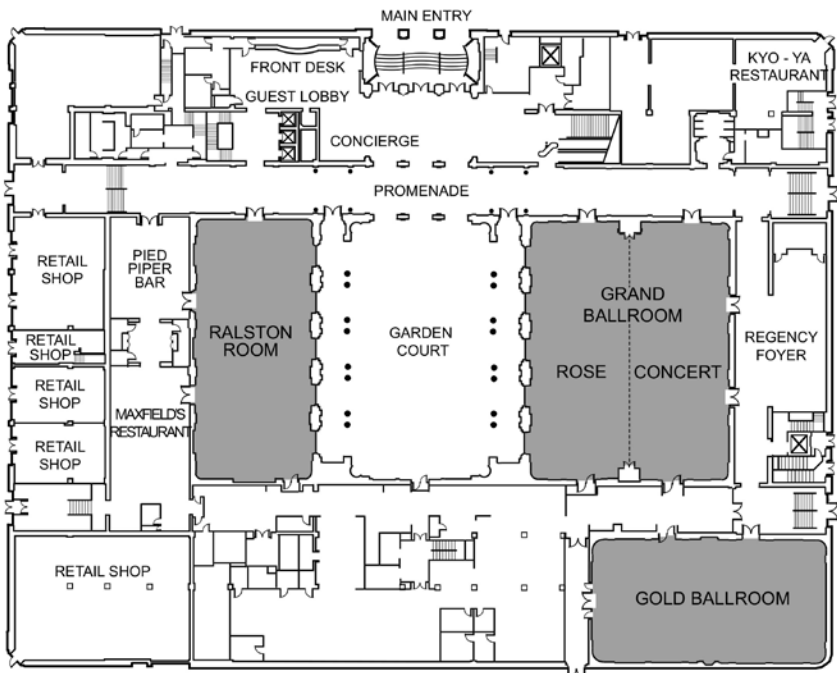

Mezzanine Level



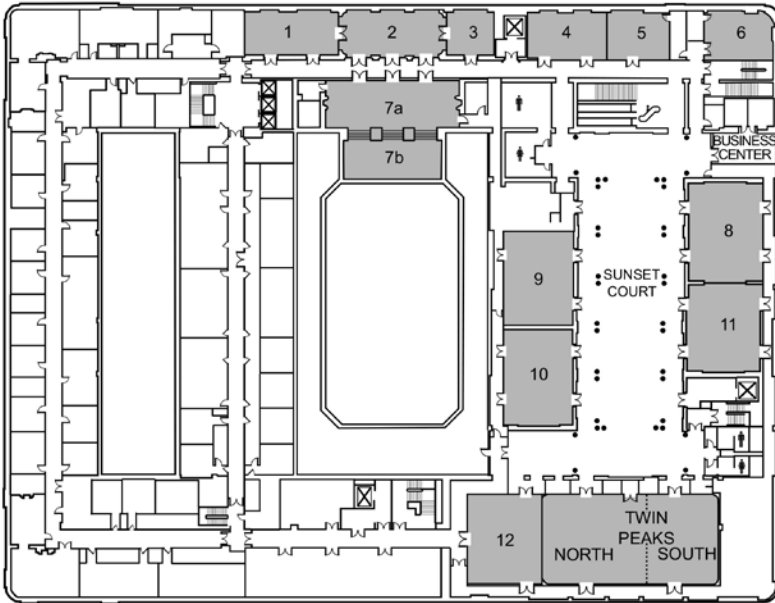
